# **Holiday Activities and Food Programme**

We need to hold personal information about you on our computers systems and in paper records to help us with the daily running of the Programme

Primary Sports Coaching Limited is responsible for their accuracy and safe keeping. Please help to keep your records up to date by informing us of any change of circumstances.

Senior staff and in some circumstance's admin staff may have access to your records to enable them to do their jobs. Anyone with access to your record is properly trained in confidentiality issues and is governed by a legal duty to keep your details secure, accurate and up to date.

All information about you is held securely and appropriate safeguards are in place to prevent loss.

In some circumstances we may be required by law to release your details to statutory or other official bodies, for example if a court order is present, or in the case of public educational matters. In other circumstances you may be required to give written consent before information is released.

#### We use data to:

- To assess entitlement to access for places on the holiday activities.
- Check with the HAF to see if funding is available.
- Ensure that funded places meet HAF requirements.

- Personal information (name, contact details, age)
- Special categories of data including characteristics information such as gender, age, ethnic group

### The lawful basis on which we process this information

We process this information under:

- Processing is necessary for the performance of a contract to which the data subject is party or in order to take steps at the request of the data subject prior to entering into a contract.
- Provision of the HAF Programme is a task carried out in the public interest or in exercise of official authority vested in the controller.

## **Collecting this information**

The information you provide to us is voluntary however without it we will not be able to offer a funded place. In order to comply with Data Protection Act, we will inform you whether you are required to provide certain workforce information to us or if you have a choice in this.

## **Storing this information**

We hold the information you provide whilst on the programme with is and for a period of 2 years following the date the programme ends.

## **Sharing of information**

We will routinely share staff information with:

- The HAF to check funding.
- Schools.
- With our admin team to arrange the programme.
- Share the registers with Stockport or Manchester Council.
- Professionals working with your family.

We may legally have to share information with other services such as the police if the law requires us to do so.

### Requesting access to your personal data
